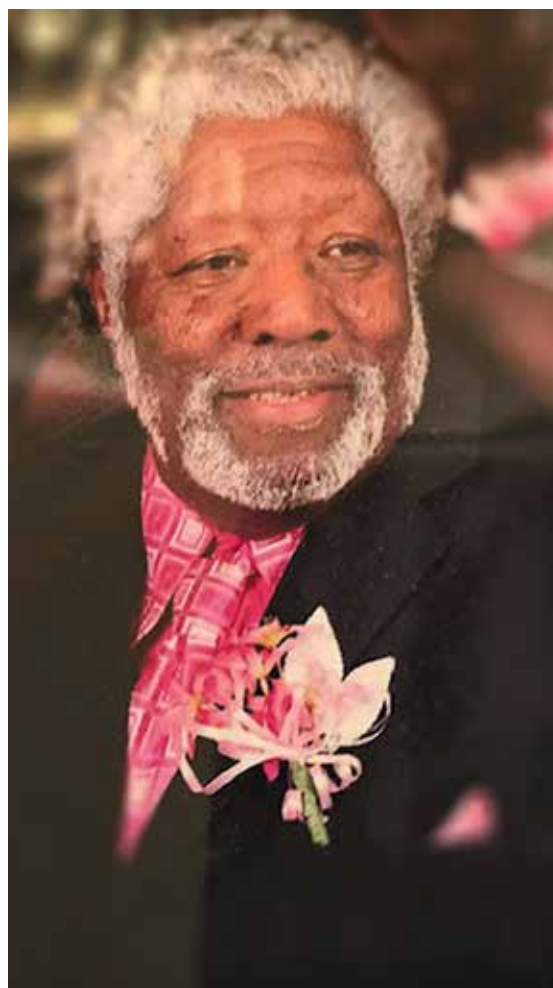

My Thoughts as CEO

George Floyd's Death & Protests

In a viral video of the incident, Floyd, who was black, was handcuffed by police Officer Derek Chauvin of the Minneapolis PD is shown holding Floyd down under his knee on the street, putting his weight on top of Floyd's neck. Chauvin, who is white, continues holding Floyd down for minutes, even after Floyd says he can't breathe. Soon Floyd is motionless, and an ambulance arrives; he's later pronounced dead at a hospital on May 25, 2020. The police involved were fired, but as of Thursday afternoon, charges had not been filed. Police were initially called on suspicion that Floyd tried to use a \$20 counterfeit bill at Cup Foods, a grocery store in Minneapolis.

The city of Racine has taken outrage, along with the Police Chief, Art Howell. He released a statement Thursday, May 28, 2020, expressing "extreme outrage" over the death of George Floyd in Minneapolis. Police Chief Howell said that while it wasn't customary for police leaders to "weigh-in" on police-related matters in advance of the adjudication process, and it is further unusual to critique sensitive matters occurring within other jurisdictions, the facts and circumstances involving Mr. Floyd's death as visually depicted are heart-wrenching and appalling. "Such conduct under the Color of Law and Order cannot be viewed as normal, justifiable, or acceptable."

"While all who are accused of crimes are afforded the full measure of Constitutional rights and protections, those who take the solemn oath to protect, serve, and to preserve life and property, have a significantly higher level of responsibility and accountability. The events witnessed on the video were shocking to the conscience of the nation, and such events, if not called out for what they represent, will erode the fabric of our nation," said Howell. "I call on police leaders near and far to take a stand in condemning this unacceptable behavior, which in turn will reveal our core values and reassure those we serve that the profession we represent is yet honorable."

And Mount Pleasant Police Chief Matt Soens said following the incident, sergeants are reminding all officers to be careful when taking suspects into custody. The Urban

League comes in to help. Their mission is to provide African Americans and all other disadvantaged groups with services to help secure economic self-reliance, equality, power, and civil rights through education, pre-employment training, youth empowerment, and crime prevention initiatives. The Urban League of Racine and Kenosha, Inc. has been an affiliate of the National Urban League (NUL) and serving the Racine and Kenosha communities since 1964. The National office has been serving people in underserved communities since 1910.

While the Urban League is not a social justice organization, it is educating the community about how to engage police officers when they arrive at a scene. The approach the Urban League is teaching is the least interaction, the better. Hall said it seems that our country's police force is trained to be aggressive instead of de-escalating and solving problems. "It's again and again and again. There seems like there's no limitation to what's happening on the streets when it comes down to these incidents with police officers and black men and women," Hall of the Urban League said. "I don't want to say they have too much power, I believe they are just over-policing." He believes these issues can be solved when the police are more connected to the communities they serve. "Without any connection to the community, these things are still going to happen. They have nothing to identify with, they don't see these individuals as people. They see them as targets."

As there were protests, some things got out of hand, but for the most part, people knew something bigger was in the making and made sure they stayed as peaceful as they could during this tough time. The Rally Monday afternoon started about 1:00pm in Monument Square, this event was Coordinated by Jacob Romanski, Voicing Racine Stands in Solidarity, about 400 young people came out to support the cause of Peace & Justice. They marched from Monument Square to The Court House and from there to the Police Station. Many sat in silence for 9 minutes in response to the 9 minutes George Floyd was held down with a Police Officers knee.

While trying to mutter I CAN'T BREATHE, other officers and bystanders did nothing to come to the aid and as-

sistance of this Black Man's Life. They had signs that read We all bleed the same, Skin Color is not reasonable, STOP Killing Black Folks, Police Brutality has to go, No Justice, No Peace, Black Lives Matter. They called out names such as Tyrese West, Donte Shannon, Trayvon Martin, and George Floyd. This massacre of killings of Black Men / Males / Boys has to come to a stop. We demand Justice Not Just justice for Blacks but for all Lives because All Lives Matter.

But tensions between the police and black communities are nothing new. There were many precedents to the Ferguson, Missouri, protests that ushered in the Black Lives Matter movement in 2014. Those precedents include the Los Angeles riots that broke out after the 1992 acquittal of police officers for beating Rodney King. That upheaval happened nearly three decades after the 1965 Watts riots, which began with Marquette Frye, an African American, being pulled over for suspected drunk driving and roughed up by the police for resisting arrest. For the past five decades, the federal government has forbidden the use of racist regulations at the state and local level. Yet people of color are still more likely to be killed by the police than whites.

The Washington Post tracks the number of Americans killed by the police by race, gender, and other characteristics. The newspaper's database indicates that 229 out

of 992 of those who died that way in 2018, 23% of the total, were black, even though only about 12% of the country is African American. Policing's institutional racism of decades and centuries ago still matters because policing culture has not changed as much as it could. For many African Americans, law enforcement represents a legacy of reinforced inequality in the justice system and resistance to advancement – even under pressure from the civil rights movement and its legacy. This truly has to stop. No one race should be treated with such disdain from others of their life as much as African American lives have been. There has been no breaking point or stop in the police brutality towards African Americans. African Americans are not animals but are treated like their trying to endanger us like a species.

All Lives Do Matter, but at this point, we are fighting for the lives of African American, minority, lives. We truly hope these protests and the much-expressed outrage shows it is not ok by any means. We have been fighting for a long time. We are in the year 2020, and people are saying, "We are still fighting racism?" Unbelievable. But the persistence of racially biased policing means that unless American policing reckons with its racist roots, it is likely to keep repeating mistakes of the past. This will hinder police from fully protecting and serving the entire public.

Kingdom Manna

I had the pleasure of visiting with Ron Tatom, who makes sure the food Pantry, Kingdom Manna, gets everything that's needed to stay afloat. This program is under Kingdom Builders and is coupled with others under this umbrella. Founded in October of 2009 by Senior Pastor Leon Brown Sr., and Co-Pastor Debra Brown, Kingdom Builders Fellowship Center & Outreach Ministry is a Non-Denominational, Bible Believing Church. The mission is to minister good tidings unto the meek; to bind up the brokenhearted; to proclaim liberty (freedom) to the captives; and to loose those that are bound in every race, culture, and nationality throughout the community, city, state and worldwide (Isaiah 61:1).

Some of the many programs they offer that go hand in hand with helping the community are the youth programs for mentoring, tutoring, and college prep. The cop houses get utilized to gather youth and bring them onboard to hear from guest speakers that look like them. Then they have the MO-SIAC program for seniors, and the Failure Is Not An Option (FINAO) program. Also, they have a relationship with RUSD Eats, Youth for Christ with the schools, Campus Life for 10-12th grades for becoming better people, leaders, and citizens. They do amazing work in the community, and it shows.

Kingdom Manna is the largest food pantry in Southeast Wisconsin based on pounds in distribution. They distribute over 2.8 million pounds of food a year, and 1.2 pounds equals one meal. This means they provide over 300,000 meals annually to people in the community. During a pandemic like this,

it is very important to have resources such as these that can benefit the people and take some stresses off them. No one should have to worry about if they can eat every day because of money being tight or not know when your next paycheck will come. Hard times come with stress, and if we can support one another in the community, that makes all the difference.

This program also partners with Feeding America, and they have been for over nine years. They are direct connect partners, so they pick up from the connections they have in Racine, such as Walmart, Aldi's, and Target. They hold all their items they get in an 8500 sqft. Warehouse. And from what I saw, they need another location because the donations they receive are plentiful. Six days a week, they travel, and they drive 20,000 miles picking up food or taking it to seniors and others who cannot make it to them as easily. They pack their two semi-trucks, five cooler trailers (48ft long), and one straight truck and get to travel.

The days they do their giveaways are Wednesday evening from 4:30-8:30 pm. Then they do another on Saturday morning from 5-9 am. They are in Horlick parking lot, and they say they are always packed. With the pandemic, there has been a 20-35% increase in people that are registering and showing up. Amazingly enough, all those who help in the giveaway are volunteers, and those volunteers were past recipients of Kingdom Manna. They are there from 7am start to 4pm 6 days (some people, they usually rotate out) with 125 volunteers in total.

Everything depends on the size of the load they get in.

People have raved about Kingdom Manna. One woman told Ron she hadn't bought groceries in two years thanks to them. The people at Kingdom Manna are blessed to do what they do. And they always do it with a smile on their faces. They serve over 5k to 6k families a month. How it works is, you register online by 12pm the previous day. Once you are registered, on Wednesday or Saturday, whichever you have chosen, you head over to Horlick field parking lot to get checked in. Once confirmed, you will go on over to the warehouse, 25 at a time because of the pandemic and to decrease contact. Once you get to the warehouse, you stay in your car and open your trunk. This allows the volunteers to stay away from you and keep you and themselves safe. And then you are on your way.

There are other food pantries through Milwaukee, Racine, Kenosha, and even Illinois sometimes, that Kingdom Manna partner with. Ron is the Director of Community Outreach and is the person to contact for

all customers and donators. Kingdom Manna appreciates all the donations and grants that they receive to keep them up and functioning the way they do. They recently received a nice size grant from S.C. Johnson. Grants are scarce, especially with everything going on in our communities and states. This makes any support extra helpful. Good faith donations are welcome and any other resources.

Now I am sure you guys are wondering what is given at these giveaways. They provide a combination of sorts. Dry food, meats, dairy, fruits, and other little things that are healthy and plentiful. Each cart they give-away carries a value of \$250-\$300 worth of groceries. That is amazing. And everyone can register 1x per week so they can be fair and give-away to a variety of people each time. It goes beyond food too. They have extra household items and baby items that people usually need. For example, diapers get expensive, and they get in donations of diapers. Also, the program is not government-sanctioned.

As I walked around the warehouse, you could see the hard work and dedication people had to help others in the community, and as Ron mentioned, they always do it with a smile. I could see ladies laughing and enjoying the ability to give back from their experiences in receiving. These volunteers are paying it forward. Pastor Leon was present, and his words were, "Every day is a super fantastic day." I appreciate having things such as this because of the times of hardship. A scripture that Ron gave me before leaving was, "If you satisfy the desire of those in need, then your days will be bright as the noonday." Isaiah 58:10. I enjoyed the atmosphere of the warehouse, and the mission is phenomenal. They do everything in all excellency.

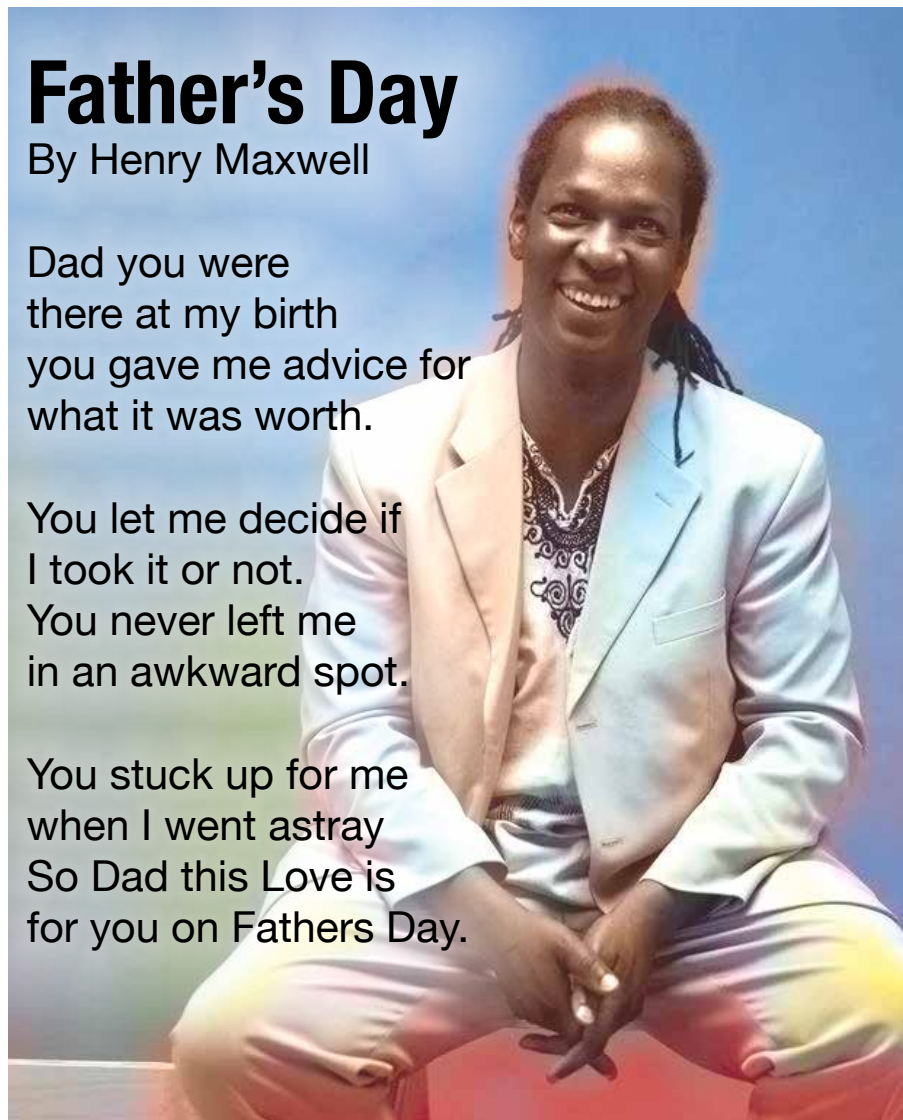
Father's Day

Big Brothers Big Sisters of Racine and Kenosha goes virtual during pandemic



Bigs and Littles are staying connected through virtual communications during pandemic.

Before the COVID-19 pandemic, adult mentors (Bigs) from the Big Brothers Big Sisters (BBBS) were working hard throughout Racine and Kenosha counties to ignite the potential in children (Littles) by striving to make a difference in their lives. They were going to the movies, watching television, bowling, hiking, playing cards, cooking and playing sports together—just to name a few.

The Big brothers Big Sisters organization's goal has always been to create and sustain meaningful mentoring connections through in-person interaction. However, COVID-19 put a pause on of their face-to-face meetings.

But all was not lost. With nudging from BBBS, Bigs and Littles have been able to stay connected through online technology sites like Zoom, Facebook, email and Messenger. Those without computers in the home are touching base by phone, text messages and mail.

We have been inspired by the many creative ways that our matches have been able to stay in touch during these trying times, said Sonya Thomas, executive director of BBBS. "We encouraged our Bigs to stay engaged with their Littles, and they have really stepped up to meet the challenge."

Bigs understand that their Little may be

experiencing great adversity in their young lives. Considered vulnerable, most come from single parent households where the primary caregiver is an essential worker. They barely earn above the federal poverty level, but not enough to support a basic household budget.

Others live in households where there is poverty and constant financial hardship. As a result, many Littles face increased anxiety, stress, fear, and worry. They cry a lot and feel responsible for the family's hardship. Bigs don't want them to worry. That's why the connection between Bigs and Littles is more important now than ever.

"They are on the frontlines helping to connect the families through virtual programs during the pandemic," Thomas said.

For 60 years, Big Brothers Big Sisters of Racine Kenosha has been building more than just friendships. "When children know they have a stable adult in their corner through difficult times, they are less anxiousness. They are also able to concentrate on school, and worry less, in spite of the fact that their lives have been turned upside down by the pandemic," Thomas said.

Before coronavirus restrictions were put in place, BBBS encouraged their Big and Little matches to meet at least once per month, but now, some matches, using

technology connections, are meeting more often. "It's great to know that the physical separation has inspired many to do even more," Thomas said.

They are engaging with virtual scavenger hunts, cooking, reading, doing homework, participating in art projects and texting together, while following the CDC's and the state's Safer At Home guidelines.

Thomas says along with ensuring Big and Little connections aren't lost due to COVID-19, the organization is stepping up to support some parents and families in need. "They are going through new difficulties and challenges so, we have stepped up the way that we provide extra resources."

BBBS is still seeking volunteers and children to meet with the growing need in our community during this difficult time. K-12 grade youth can enroll on our web page. Also, any adult 18 or older willing to make a difference can volunteer. "You don't have to do drastic things to change a child's life. Just be there and be willing to spend at least 1.5 hours of quality time with them once a month.

What constitutes an emergency fund and why is it so important to have one, particularly in times like this? Here’s a primer.

Financial solvency matters. Financial experts generally encourage you to set aside three to six months’ worth of living expenses in an emergency fund. Without it, you are at risk of losing what you’ve worked hard to achieve if life throws a curve ball. A stash of funds can help you meet your monthly obligations, keep your credit report clean and preserve your way of life.

Put your priorities in order. An emergency fund deserves to be at the top of your list of financial priorities. Emergency reserves are designed to provide a safety net to prevent financial disaster. Your tax refund is another potential source of cash to grow an emergency fund. Revisit your current budget to see where you can trim expenses and put more into savings.

Create and stick to your guidelines. Your emergency fund should be reserved for times of financial crisis. It’s not an account to pay for life’s extras, however tempting that may be. With guidelines in place, you can avoid dipping into these funds unless necessary.

Keep emergency funds within safe reach. When uncertainty strikes, you may need money in a hurry.

For this reason, emergency savings should be held in cash or easy-to-access investments like a money market fund. You also may want to open a dedicated interest-bearing savings account, potentially in a bank separate from your other accounts, to keep your emergency funds at a safe distance if you’re one who may be tempted to spend it.

City of Racine limits mass gatherings through July 31

RACINE — The City of Racine Public Health Department on Tuesday issued an order limiting mass gatherings of people through July 31.

The order applies to planned and spontaneous public events, including festivals, block parties, use of city park pavilions and all other events which require city approval or permits, according to a City of Racine news release.

According to the order, mass gatherings of any kind outside of a household unit are not allowed through July 31.

“As we continue to address the spread of COVID-19 in the community, we know that large gatherings present a direct threat to public health. One asymptomatic individual can infect dozens or more people and cause an outbreak,” Public Health Administrator Dottie-Kay Bowersox said.

Events scheduled to occur after July 31 will be reviewed by the public Health Department in the coming weeks and approval or denial of those events will be based on the best data relating to the prevalence and spread of COVID-19 in the community, city officials stated.

“The city now has over 700 confirmed cases of coronavirus, when just a week ago we were at about 460 cases. That is why today I have issued an order to stop all large events that require city approval until July 31, 2020,” Bowersox said. “Events currently being planned or scheduled to happen after that date will be evaluated based on what the spread of coronavirus looks like in the community over the coming months.”



As of Monday, more than 700 cases of COVID-19 have been confirmed within the jurisdiction of the City of Racine Health Department, which also includes Wind Point and Elmwood Park. There are another 355 confirmed cases in the rest of the county, and 20 deaths countywide.

The greater Racine area remains in the top 20 nationwide in terms of the rate of spread of the coronavirus, according to public data compiled by The Upshot and The New York Times.

Racine currently ranks third both in the total number of cases and has the third-highest per capita rate of positive COVID-19 cases in the state. Racine County is the state’s fifth most populous county, behind Milwaukee, Dane, Waukesha and Brown counties.

“I want to also clarify that this order is in addition to and separate from the city’s extension of the “Safer at Home” order which expires on May 26,” Bowersox said. She said that later this week, she plans to is-

sue orders giving businesses and residents guidelines on what will be a phased and gradual reopening of the local economy.

Emergency declaration

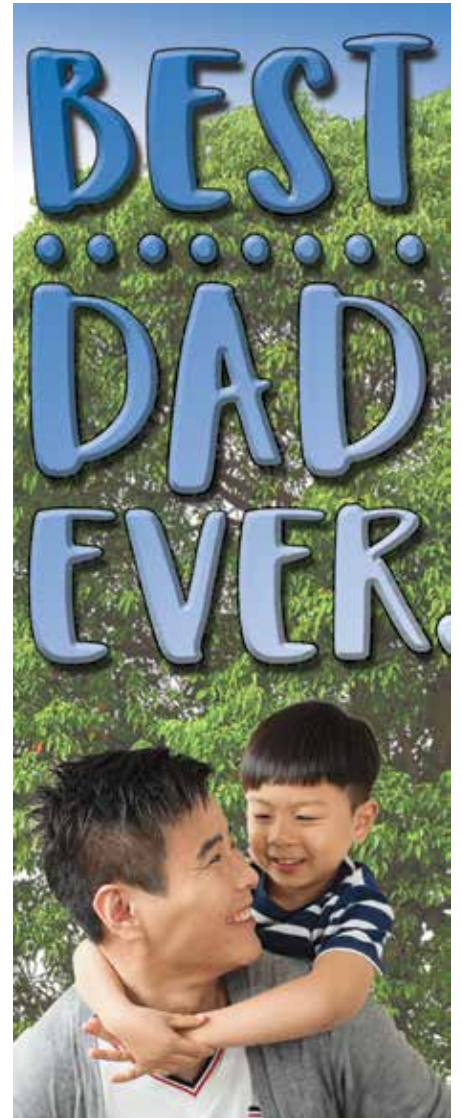
The announcement of the Health Department order was made after it was learned that Mayor Cory Mason planned to ask the City Council tonight to allow the city’s declaration of emergency related to COVID-19 to extend until July 31.

The current emergency declaration, which was ratified by the City Council on April 20, is set to expire at 11:59 p.m. on Monday. Emergency declarations give greater powers to administrators, like the mayor and public health officer, to enforce and create rules. They also allow municipalities to direct resources more quickly to address a crisis, such as a natural disaster or pandemic.

The emergency declaration is separate from the Safer at Home order; they are distinct edicts.

Wisconsin Attorney General Josh Kaul, after the Supreme Court overturned Safer at Home, said that municipalities and public health departments should still be able to legally enforce restrictions due to COVID-19 if the novel coronavirus is an active threat in the community.

Before being overturned, Safer at Home statewide was supposed to end May 26. Racine extended its order based on advice from the city attorney that the city had the authority because it has its own public health officer.

We are done dying wrongfully at the hands of racist individuals and these individuals not being held accountable for their actions.



Hey, What About Our Health?

Are masks, gloves, social distancing, drug, vaccine the only Covid-19 answer?

Of course not, but it sure sounds or looks that way. All I hear in the news and on TV is about masks, gloves, social distancing, testing, and hope that a drug or vaccine will come to the rescue. There is little, less about our health, and the role and importance of it when that is exactly what we need to be working on just as much as anything else.

Especially when you hear about a possible reoccurrence or there could be something else. If you think we are "one and done" with Covid-19, you may be mistaken. So, say there is a Covid-22. Then what---more masks, gloves, social distancing; another drug, another vaccine that may not ever be found.

WHAT REALLY MATTERS

No, STOP! that's all a dead end, a "band-aid". The attention and focus must be put on what really matters, is the "real deal". That's our health and making our health, body and immune system as healthy and strong as it can be. That's what will ultimately save us and be the answer we are looking and hoping for.

IT'S NOT WHAT YOU THINK

A reaction might be, oh it doesn't matter what my health is. I could or could not get a virus.

Hold on for a moment and realize this. It's not only about whether you get a virus or not, but HOW WELL CAN YOUR BODY FIGHT and move it out of your system. Just how good or not is your health and immune system to do that. That is the question.

We know how some are not affected that



much about having Covid-19 or other viruses while others are devastated or wiped out.

Furthermore, having a weak, useless immune system can be due to POOR HEALTH, NUTRITION, DIET and not just a compromised immune system because of age or some preexisting condition.

Just look at the sorry, dreadful state/condition our health is in.

- Overweight you look around and see on our bodies;
- Our lousy; health, life-threatening junk, processed "food" diet saturated with unhealthy, addicting sugar, salt and oils;
- Widespread disease, sickness, "aches and pains" and consumption of prescription and over the counter drugs you see and hear about so much, too much;
- Those feeling fine, no sign of any problem, okay diet, good physical. Then all of a sudden wham-bam heart attack, cancer,

diabetes or alzheimer's/dementia;

• Prescriptions, medications needed to keep us going; alive, and that compromise beyond repair proper functioning of our body's organs!

• On top of all that, properly prescribed and used prescription drugs, and the adverse drug reactions from them are "a major health risk, ranking 4th with stroke as a leading cause of death" (Light, New Prescription Drugs, 2014)!

As a result of all that, we have been "asking for it" and a "sitting duck" for Covid-19 or any virus, and all the diseases you see or hear about the most. So, is it really any surprise that something like Covid-19 came in and caused the mayhem that it has?

HARD, HONEST LOOK

That means having to take a hard, honest look at our health, nutrition, diet and realize this. That viruses, diseases like heart attacks, cancer, diabetes, alzheimer's/dementia are SYMPTOMS, NOT CAUSES. They are signs, warning signs; flashing neon lights that something is just not right with our health, body and immune system.

One might think or say, really, what do you mean by that; show or "prove it" to me.

TO BE OR NOT BE HEALTHY THAT IS THE QUESTION

Okay, I have some questions for you about the basics, fundamentals or essentials of health and OF LIFE, and what life can be like. Whether it's longer or shorter; a comfortable, enjoyable one, or miserable and full of "aches and pains" and pills.

1 Are you exercising—on a regular, consistent basis? If so, how much. It should be about 30 min daily.

2 What's the amount of water that you are drinking each day? It should be 7-8 glasses to begin with.

3 Are you eating fresh fruits and vegetables each day? If so, how much? It should be at least a bowl full of different kinds of fruit and a good size salad with lots of different vegetables every other day at least.

4 How much sleep are you getting? It should be 8 hours.

5 Are you taking a multivitamin each day? And any supplements because of the number of common vitamin, mineral deficiencies that have to be taken care of.

6 Are you cutting down on junk, processed "foods" saturated with unhealthy, addicting sugar, salt and oils? (How? By putting something in its place like fresh, plant-based food,

that's the trick.) Maybe not one of the basics, but essential.

THAT'S NOT ALL

Now listen to this. Here is what's important to know and realize about those 6 fundamentals of health and life, and whether we HAVE IT OR NOT.

Our body is a total, integrated, complete system where every part of it works together like a machine; is interdependent upon one another like pieces to a puzzle or instruments for a symphony. You can't have one without the other. You can't have a right hand without the left hand; the left leg without the right leg.

So that means doing ALL 5 BASICS and 6, and not just 2 or 3 or half done. You, can't be exercising and drinking the water your health and body needs, but not getting the sleep, and vitamins and supplements they require.

Well, geez, at least I got 6 hours of sleep and 15 minutes of exercise. No, all of the health and life essentials have to be done-completely, thoroughly. That's the "fast track" to:

♥ STRONG AND HEALTHY BODY AND IMMUNE SYSTEM, and the best protection, offense/defense against viruses, diseases, sickness, "aches and pains", and

♥ Optimal Health, Wellness and Prevention Freedom (free as possible from virus, disease, sickness and drugs).

City says Safer at Home order will not remain fully in effect through the end of July

RACINE — Although many of Racine's small-business owners fear the City of Racine will force them to stay closed through the end of July, city leaders say they shouldn't worry.

Public Health Administrator Dottie-Kay Bowersox said that, before the week is out, she will be detailing phases through which business owners in every industry will be able to legally reopen in the city.

Mass gatherings, such as events at the beach or at Festival Hall or that involve a street closure which need approval from the city, will not be allowed until Aug. 1 at the earliest.

"This week, we will make that (plan) clear to the community as a whole," City Spokesman Shannon Powell told The Journal Times Tuesday morning. "It will not just be a continuation of the order that's in place now."

Business owners are still concerned. When word got out that Mayor Cory Mason plans to ask the City Council to approve keeping the city's emergency declaration in place until July 31, many started to fear that the Safer at Home order would be extended too.

The emergency declaration and Safer at Home are separate orders.

'Really worried'

"I'm really worried for Racine in general. It's more than just me," said Alex Ersing, who owns Mt. Sinai Gym, 2005 Lathrop Ave. Now that most of the rest of the state has



reopened after the Wisconsin Supreme Court overturned the Wisconsin Department of Health Services' Safer at Home order on May 13, customers are bringing their business elsewhere while many of City of Racine's businesses remain closed. Some, such as dog groomers and retail shops, are able to be open with limited numbers of customers.

"You've got Kenosha open. It's 10 minutes away. People are going to their bars, to their gyms," said Ersing, whose gym is still entirely closed. "In Walmart, you've got 10 people in a line ... but we are shut down."

Evelyn "Evie" Kalmar, who owns Unplugged Studios at 1352 Washington Ave., said "I think it's absurd to me that Mount Pleasant and Kenosha are open, and Racine isn't."

Kalmar thinks Racine should follow the lead of most other cities in the state: allow businesses to reopen, but put protocols in place to ensure safety, such as limiting the

number of people who are allowed to gather in a building as a fraction of its capacity.

"Some of my venues are humongous. If I had 50 people in there, you could maintain six feet of space easily," she said.

Kalmar's and Ersing's businesses are both stuck in a spot where it's virtually impossible to make revenue from home.

"90% of the work that I do is face-to-face contact," Kalmar said.

Ersing fears people who normally belong to his gym in Racine will give up and start going elsewhere, making it difficult to stay open even after Racine's closure order is lifted.

Kalmar said she has already had to take on debt over the past couple months. She said the money she has received from COVID-related grants she has received don't even cover half of her ongoing expenses.

"Even if I took out loans, I don't know if I'll be able to bounce back," she said.

Powell notes that the city is in a no-win scenario. Keeping businesses closed isn't good for the local economy or businesses and workers, but allowing them to reopen too early could lead to the coronavirus spreading too fast for the health care system to handle.

Even with the order still in place, the greater Racine area ranks among the top 25 areas in the country in terms of how fast COVID-19 has spread.

"You can't fight a public health hazard just thinking about economics," Powell said.

2020 Independence Day Celebration: Things will look different this year

We had an open discussion with the City, and the safety of the community is everyone's top priority. But we do feel that this community deserves the chance to celebrate. We are not going to stop our 84-year long tradition."

"We know we need to allow people to celebrate the 4th, but it has to look different this year in the face of this pandemic. I sincerely appreciate the partnership with the 4th Fest Board to come up with this innovative approach for us to bring the parade to the people so that we avoid large gatherings that certainly could lead to a larger outbreak of COVID-19. I know this year will not feel normal, but I am confident that next year's 4th Fest will be bigger and better than ever," said Mayor Cory Mason.

4th Fest continues to work hard at fundraising efforts as it is a private, non-profit organization that is funded through the generosity of individual and corporate donations. 4th Fest is currently participating in the Do More 24 campaign through United Way of Racine County. 


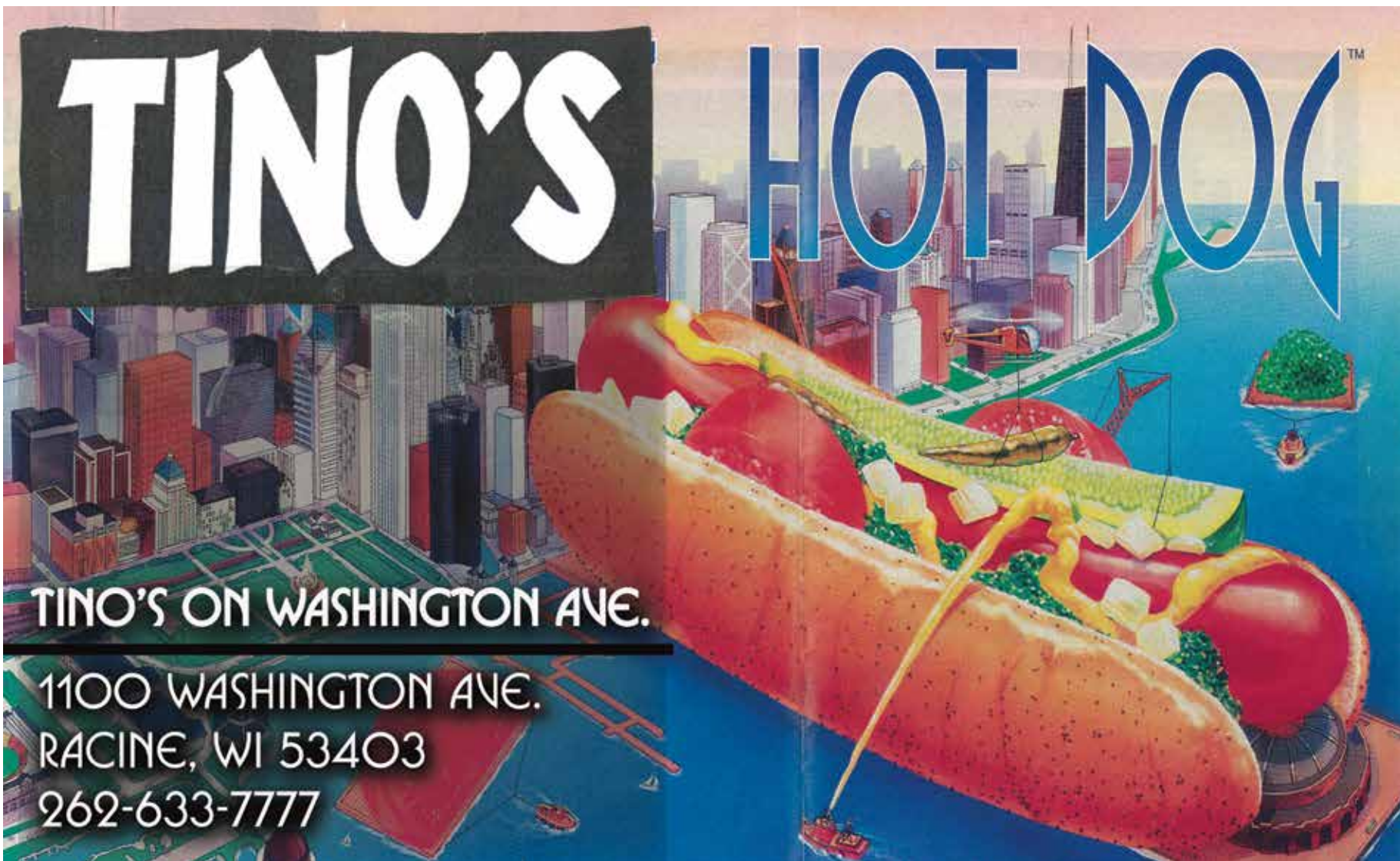
